

## **UNEDasiss 2017 CALL FOR REQUESTS**

The accreditation procedures for international students of UNEDasiss shall begin to function in 2017, for admission to Spanish universities in the 2017/2018 course year.

The call for request for accreditation is opening 15th March. From the <u>UNEDasiss</u> website, it is possible to access the computerized requests application.

The prices to be paid for the UNEDasiss accreditations have been approved by the Governing Board of the UNED and by its Social Council. The approved prices for the distinct accreditation services are the following:

## Refunding of paid quantities

Students should pay the prices corresponding to all of the accreditation services requested, although these may be denied by UNEDasiss, upon examination of the documentation provided.

Having sent the application, the student may not eliminate services that have already been requested, although they may modify services or increase the accreditation services that they have requested. Modifications that do not imply a decrease in the prices to be paid and that have been requested prior to the issue of accreditations or the deadline for requesting PCE shall be accepted.

The request for recognition of a new course should be paid, although the resolution of this request may be negative.

In general, refunding shall only be offered for amounts paid in the following cases:

- Duplicate payments for the same item.
- When the service has not been provided due to causes attributed to UNEDasiss.
- When the student does not comply with the minimum requirement demanded for university admission and verification by UNED is carried out.
