

2021 online LLM Summer Schools in Private Int'l Law & Public Int'l Law.

The EDELNet Partnership is delighted to announce that we are inviting applications to the two simultaneous annual EDELNet LL.M. Summer Schools in Private Int'l Law and Public Int'l Law that we offer this year as **online programmes**.

The online LLM Summer Schools will focus on the active interaction and socialization between students (enrolled in Phd Uned Programs/Uned Masters) and lecturers from the FernUniversität Hagen (Germany), the Open Universiteit (Netherlands), UNED (Spain) and Open University (UK). 24 LLM students and 8-10 lecturers from different European jurisdictions will e-meet and have the opportunity to work together in a series of group activities and discussions designed to offer students a high quality learning experience with a taste of real lawyering work.

The programme is organized as two simultaneous Moot Courts. It begins with an online **preparatory phase in April** during which participants are expected to work their way through some basic reading with the support of online lectures and Q&A sessions.

Structured around the professional processing of one moot problem, **the second phase of the programme begins on 17 May**. During this phase students will be assigned to a cross-national litigation team with the role of defending its client's or institution's interests. Through their participation in the moot litigation teams, students are expected to get acquainted with a set of legal professional tasks that will help them become aware of the intricacies of the real operation of the law in practice and learn how to argue using the language of the law in different legal contexts. In the course of the programme students will receive structured and intensive training not only in legal matters, but also in soft skills such as academic debate, legal English and team work.

Online moot court (19-23 July) – 2.5 hours max as per Rules of Procedure
Evaluation
Participating teams receive oral feedback at the end of online session Lecturers grade teams' performance after the session Students receive an official grade (ECTS) from their respective institutions

In order for us to better process your applications, we kindly ask you to indicate in which of the two Moot Courts you would like to participate (PrivLaw or PubLaw).

Applicants must send an email with the CV and Cover Letter in english for enrollment in the Summer Schools.

The Coordinator Team will select students from each participating Institution according to academic criteria (CV and cover Letter).

Successful applicants are expected to be registered as students at one of the organizing institutions and *have a good command of English.*
